### Current situation:

In our February Newsletter I predicted that Buntings would re-submit their Planning Application before the end of March. I was wrong and it now appears that they will be holding a series of 'consultation' events in May and June with the submission of their Application sometime after these.

Our view is that this so-called 'consultation' is to make their Application look good for the Council, but it is hard to believe that they will make any significant changes as a result. You may wish to go to these meetings which are to be held in the Town Hall in Colchester on May 10<sup>th</sup> and 12<sup>th</sup>, Great Horkesley Village Hall on May 11<sup>th</sup> and are open from 10.00am to 8.00pm on the 10<sup>th</sup> and 11<sup>th</sup> and 5.00pm on the 12<sup>th</sup>. There will be further opportunities to see the plans at the Chantry the following week from 10.00am to 5.00pm. Please do not be taken in by the Bunting 'spin'; look underneath for the retail, traffic, noise, urbanisation of countryside issues etc that are so abhorrent and make your feelings known to them and their experts.

### Rosenthal Lecture:

## "Who owns Constable's Country"

A look at Constable Country, then and now: the changing demands we have placed on the landscapes Constable painted, which are so firmly inscribed on our collective memory.

Professor Rosenthal is professor of Art History at Warwick University and is one of the leading authorities on John Constable and Thomas Gainsborough. He grew up in Great Horkesley and, like Constable, spent 'a careless boyhood' on the banks of the Stour, mainly fishing at Wiston. He was made aware of our plight by one of the television programmes last time around and is very concerned that the valley of John Constable should not be exploited.
